

NEW ZEALAND SCRAPS WORLD-FIRST SMOKING 'GENERATION BAN' TO FUND TAX CUTS NOVEMBER 26, 2023 SOURCE: LINK

New Zealand's new government will scrap the country's world-leading law to ban smoking for future generations to help pay for tax cuts – a move that public health officials believe will cost thousands of lives and will be

"CATASTROPHIC" FOR MĀORI COMMUNITIES.

In 2022 the country passed pioneering legislation which introduced a steadily rising smoking age to stop those born after January 2009 from ever being able to legally buy cigarettes. The law was designed to prevent thousands of smoking-related deaths and save the health system billions of dollars.



"This is major loss for public health, and a huge win for the tobacco industry – whose profits will be boosted at the expense of Kiwi lives," -Prof Lisa Te Morenga "This move suggests a disregard for the voices of the communities most affected by tobacco harm – favouring economic interests," - chief executive Jason Alexander.



The legislation to phase out smoking for future generations, contained a slew of other measures to make smoking less affordable and accessible. It included dramatically reducing the legal amount of nicotine in tobacco products, allowing their sale only through special tobacco stores, and slashing the number of stores legally allowed to sell cigarettes from 6,000 to just 600 nationwide.

The laws were due to be implemented from July 2024. But as part of its coalition agreement with populist New Zealand First, National agreed to repeal the amendments, including

HOW BIG TOBACCO STILL TARGETS LGBTQ PEOPLE THROUGH ADS

LGBTQ individuals consume tobacco products at much higher rates than their heterosexual counterparts—with certain populations, like sexual minority women and transgender individuals, reporting more than three times higher use of cigarettes than their cisheterosexual counterparts.

"CAREFULLY CRAFTED THEIR ADVERTISING TO THE LGBTQ COMMUNITY."

Research funding for LGBTQ communities largely goes toward work on HIV, sexually transmitted infection testing, and HIV-preventing pre-exposure prophylaxis. Less than 3% of National Institutes of Health funding goes towards research on prevention and cessation of tobacco use..



TARGETED ADS PLAYED ON LANGUAGE IMPORTANT TO THIS COMMUNITY, INCLUDING TAGLINES MENTIONING "PRIDE" OR "THE RIGHT TO CHOOSE."



This is no coincidence, said LDI Senior Fellow Andy Tan, PhD, MPH. The tobacco industry's marketing has "systematically targeted" the LGBTQ community for decades, said Tan.

Rather, marketing has shifted from targeting by demographics to targeting by psychographics, Tan said. With psychographics, the tobacco industry can tailor advertisements to interest groups, such as certain fashion or video game communities where LGBTQ individuals are more represented.

WHY SMOKEFREE OUTDOOR DINING IS IMPORTANT

- » Even outdoors, there is no safe level of exposure to secondhand smoke.
- » Breathing secondhand smoke can increase the
- risk of lung cancer, heart disease, and stroke.
 Secondhand smoke from vaping, cigarillos, hookah, and marijuana contains many of the same toxic chemicals as cigarette smoke.

JOIN THE SMOKEFREE OUTDOOR DINING MOVEMENT

- » California's Smokefree Workplace Law prohibits smoking and vaping in all indoor workplaces including restaurants and bars but does not apply to outdoors.
- » Hundreds of cities, counties, and restaurants have adopted smokefree outdoor dining and bar patio laws—and so can you!
